This story of a grumpy bookstore owner, a mysterious child left at his shop, and a 2nd chance at life that he never saw coming gives the reader a wonderful glimpse at a quiet and well lived life. Mother and daughter find their way through their community and a bookstore to survive during the dark times of WW II.



## HURRICANE PREPAREDNESS TIPS

GEICO encourages you take these steps to prepare yourself, your loved ones, and your car from dangerous weather.

#### Review your emergency plan

Review your plan with everyone in your household and make sure everyone knows about the safest location in the home.

### Check your supplies

### Set up an out-of-town contact

It's important to have an out-of-state friend or family member as a contact, so they can check on your whereabouts.

## Secure important documents

## Figure out your evacuation route

Make sure you know your evacuation route before the storm hit



the storm hits and keep a full tank of gas.

### Be aware of your vehicle's surroundings

Make sure your vehicle is safe. If possible, move your vehicle away from trees or other objects that may damage it in a storm.

### Follow official instructions

Follow all instructions from your local authorities regarding evacuation or other safety procedures.



Check radio, television or other media for emergency information.





#### FIREWISE ACTIVITIES MATCHING FUNDS RECORDING SHEET

Can be used to record activities for matching funds and other Firewise Communities/USA

What qualifies for matching funds for Firewise grants? Any time or money you spend on your home and/or surrounding property for the purpose of reducing the probability of wildfire loss. Examples of activities that will qualify related to homes and outbuildings are:

Dryer vent cleaning, pruning, mulching, tree trimming/limbing, weed abatement/spraying, replacing combustible mulches with stone/gravel, leaf raking and removal, pine needle/pine cone removal, cleaning gutters, grass cutting, grass irrigation, edging, time spent hauling vegetation to landfill/dump sites, meetings, presentations, cost for purchase or rental of chain saw/hedge trimmers, cost or protective eyewear/earplugs.

Volunteer activities also qualify for Firewise matching funds. Volunteer activities can include: attending Firewise Board Meetings, attending Firewise community events and preparation for wildfire.
